



## Affidavit of Financial Support for International Students

All students who require an M-1 visa are required by U.S. government regulations to provide financial documentation to support their tuition, fees, and living expenses for the duration of their program of study in the U.S.

The total support amount must be equal or greater than the amount shown on the I-20. Financial documentation of adequate funds must be submitted in the form of a recent (within the last 3 months) bank statement or other financial documentation (loan statement, government funds, certificate of credit) and must include the sponsor's name. An I-20 CANNOT be issued until proof of adequate funds is provided. If you are receiving government sponsorship, a letter of support stating the exact terms and length of the scholarship including any provisions must be provided.

## Amounts Based on Program of Study

***Living Expenses are estimated at \$2,000 per month. The student may spend more or less than that depending on their spending habits.***

The amounts below must be demonstrated in order for The Lee Strasberg Theatre & Film Institute to issue an I-20 and to obtain an M-1 visa. These amounts include tuition costs, fees, plus the estimated living expenses of \$2,000 a month.

### 12-Week Session

$$\$5,765 + 6,000 = \$11,765$$

### Two 12-Week Sessions

$$\$11,530 + \$12,000 = \$23,530$$

### One Year Conservatory

$$\$16,750 + \$18,000 = \$34,750$$

### Four 12-Week Sessions/ One Year Conservatory + 12-Week Session

$$\$22,515 + \$24,000 = \$40,750$$

### Two Year Conservatory

$\$22,515 + \$24,000 = \$40,750$  (Sufficient funds for 1<sup>st</sup> year of study must be demonstrated. You do not need to show sufficient funds for the length of the entire program.)

**Tuition must be paid in full before I-20 issuance. If enrolling in the One or Two Year Conservatory, you can pay by session, or pay the entire program cost and receive a discount.**
